Note: The Department of Justice sent letters to a group of cities believed to have so-called 'sanctuary policies' asking them to prove their compliance with a federal statute that promotes information sharing related to immigration enforcement. Several of the jurisdictions found to be in compliance are not included on this list. The DOJ has only made preliminary determinations in regards to five: New Orleans, New York City, Philadelphia, Chicago, and Cook County, Ill. No final determination has yet been made about the other jurisdictions. The DOJ sent Milwaukee a letter earlier this year but found the city was in compliance and the previous sheriff applied for the 287(g) program. Through Freedom of Information Act requests and interviews Reuters found at least 38 jurisdictions that said they are interested in the 287(g) program or have already applied. While ICE provided a longer list of jurisdictions through FOIA of jurisdictions expressing interest, nearly half contacted by Reuters said they were not interested or were not familiar with the program.
